

# **Installation Notes**


Install this product according to the installation guide. **IMPORTANT!** Due to the large size of the bathroom sink, a 21-1/8" (537 mm) wide flat surface is required for installation on a vanity top.

Bathroom sinks without faucet holes require wall-mount faucets with 7'' (178 mm) minimum spout length.

Supply dimensions are based on a  $12^{\prime\prime}$  (305 mm) riser which may require cutting.

**NOTICE:** Countertop manufacturer or cutter **must** use the cut-out template provided with the product, or a current one provided by Kohler Co. (call 1-800-4KOHLER). Kohler Co. is not responsible for cut-out errors when the incorrect cut-out template is used.
